**SUBJECT:** Resolutions Continuing Salaries and Benefits Pursuant to the Current Agreements with American Federation of State, County and Municipal Employees (AFSCME), Local 146 and the Sacramento Housing and Redevelopment Agency Employees' Association (SHRAEA), beyond the expiration date of December 21, 1984

SUMMARY

The agreements between American Federation of State, County and Municipal Employees, Local 146 and the Sacramento Housing and Redevelopment Agency Employees' Association expire on December 21, 1984. Therefore, since new agreements cannot be reached and approved by December 21, 1984, it is requested that salaries and benefits pursuant to the current agreements be continued. In the event agreement is reached by December 21, 1984, staff will return to the Governing Board on January 8, 1985 with the agreements which will be retroactive to December 21, 1984.
