SUBJECT: Resolution Authorizing Execution of Agreement Between Metropolitan Civil Engineering Company and the City of Sacramento for the Preparation of Improvement Plans for Del Paso Heights Street Assessment District No. 5

SUMMARY:

Presented herewith for approval is a consultant services agreement for an amount not to exceed \$10,725.00 between Metropolitan Civil Engineering Company and the City of Sacramento for the preparation of engineering plans for the Del Paso Heights Street Assessment District No. 5 (South of Nogales to Arcade Creek, East of Alvarado to Marysville Boulevard).

BACKGROUND:

This agreement is presented to conform to the guidelines of the policy for Retention of Professional Consultants for City Projects adopted February 26, 1980. The charges shall represent hourly charges for personnel involved in the work, materials, supplies, stakes, mileage and prints needed in the work process, with the total fee not to exceed \$10,725.00. On October 7, 1980, the City Engineer executed an agreement for a not to exceed amount of \$19,900 for the subject project with Metropolitan Engineering for drafting and right-of-way computation services. Due to the current in-house workload, it is necessary to expand the scope of the services to include full engineering design.

FINANCIAL:

Funds for the subject project are available from the City Engineer's Operating Budget. These funds will be recovered from Community Development Block Grant revenue upon completion of the project.

It is recommended that the City Manager and City Clerk be authorized to execute the
