Summary

This report recommends adoption of an ordinance to clarify that the Construction Codes Advisory and Appeals Board hears appeals of fire code interpretations and requirements.

Background

Chapter 15, Article II of the City Code adopts the 1982 Uniform Fire Code (UFC). Certain sections of the UFC are deleted or amended.

Section 2.302 was not deleted when the 1982 UFC was adopted. Section 2.302 provides for a fire code Board of Appeals. As such, it conflicts with Section 9.584 of the City Code which provides that fire code appeals shall be heard by the Construction Codes Advisory and Appeals Board as set forth in Article XIX of Chapter 9.

The proposed ordinance would delete UFC Section 2.302 and provide that Article XIX of Chapter 9 applies to fire code appeals.

This ordinance was reviewed and approved by the Law and Legislation Committee on April 3, 1986.

Recommendation

It is recommended that the ordinance adding Section 15.201-1 be passed for publication and continued to April 22, 1986 for hearing.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

Section 15.201-1 is hereby added to the Sacramento City Code to read as follows:

Sec. 15.201-1 Appeals

Section 2.302 of the Uniform Fire Code is deleted. All appeals described in section 2.302 of the Uniform Fire Code shall be governed by Article XIX of Chapter 9 of the Sacramento City Code or any successor provisions thereto.
