SUBJECT: Renewal of Abandoned Vehicle Abatement Program

SUMMARY:

An Agreement has been negotiated with the California Highway Patrol to continue the City's participation in the State Abandoned Vehicle Abatement Program for the Fiscal Year 1980-81. City Council approval is required. In addition, Authorization for the Senior Field Representative in the Building Inspections Division, Edwin F. Carlson, to act in behalf of the City Manager to execute the Agreement, is requested.

BACKGROUND INFORMATION:

The City has had a contractual agreement with the California Highway Patrol to remove abandoned vehicles from private property for the past eight years. Each year, a new Agreement must be negotiated. The City has abated approximately 3,197 vehicles dating from the Program's inception (1973) through calendar year 1979. The same procedure has been used each year in negotiating and executing the agreement.

FINANCIAL DATA:

Last year, we negotiated an Agreement in which it was stipulated that the California Highway Patrol would reimburse the City \$60.00 per vehicle abated under the Program. The City abated fifty-nine vehicles for a total reimbursement of \$3,540.00 during the 1979/80 contract year. We feel the \$60.00 per vehicle reimbursement figure is still valid and will continue this rate under the new contract.

FINANCIAL DATA (Continued)

It is estimated that one hundred vehicles will be abated during Fiscal 1980/81. This figure can be increased if necessary.

Through calendar year 1979, the City has received \$65,910.00 total reimbursement from the State under the Abandoned Vehicle Program.


RECOMMENDATION:

It is recommended that the City Council adopt the attached Resolution approving the Agreement with the California Highway Patrol and the Senior Field Representative, Building Inspections Division, be named to act for the City Manager and be authorized to execute this Agreement.
