GENERAL MUNICIPAL ELECTION RESULTS

LOCATION AND COUNCIL DISTRICT

Districts 7 and 8.

SUMMARY

Request for adoption of Resolution declaring the official results of the November 3, 1992 General Municipal Election as submitted by the County Registrar of Voters.

RECOMMENDATION

Adopt the attached Resolution.

BACKGROUND INFORMATION

On Tuesday, November 3, 1992, the City of Sacramento held a General Municipal Election for the purpose of determining a new representative in Council District 8, and to allow for the voters of District 7 to decide a question of recall.

On November 17, 1992, the Council received for filing the "unofficial returns" in order to proceed with oaths of office. It is necessary to certify the "official returns" which have now been received.

Pursuant to the results contained in the Certificates of Fact from the County Registrar, it is hereby determined that: 1) the percentage of votes received by Sam Pannell are sufficient to declare him elected to the Council District 8 seat; and 2) that the number of "NO" votes cast, in the question of whether to recall Terry Kastanis as Councilmember to District 7, were of sufficient majority to declare the recall unsuccessful.

FINANCIAL CONSIDERATIONS

The County's charge to the City for providing election services in connection with the District 7 and 8 elections is \$6,460.

POLICY CONSIDERATIONS

This is in compliance with the Council resolution authorizing the County Registrar of Voters to canvass the election returns.

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SACRAMENTO, CALIFORNIA, RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 3, 1992, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Sacramento, California, on Tuesday, November 3, 1992, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California; and

WHEREAS, pursuant to Resolution No. 92-060 adopted January 28, 1992, the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SACRAMENTO, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. That the whole number of votes cast in City Council Districts 7 and 8, including absentee ballots, was 37,242.

Section 2. That the names of persons voted for at the election and the results of the votes cast are as follows:

<u>District 8:</u>	<u>Votes Cast</u>
* Sam Pannell	7,587
Michael Reyna	6,307

The City Council does declare and determine that Sam Pannell was elected as Councilmember to District #8 for the full term of four years.

Section 4. That the question of recall that was voted on by the voters of District 7 is as follows:

"Shall Terry Kastanis be recalled from the office of City Councilmember of District 7?"

Yes 6,740 No 8,610

The City Council does declare and determine that as a result of a majority of "NO" votes cast, the recall is hereby declared to have been unsuccessful.

Section 5. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates, and for and against the measure, are as listed in Exhibit "A" attached.

Section 6. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: 1) The whole number of votes cast in the City; 2) The names of the persons voted for; 3) The measure voted upon; 4) For what office each person voted for; 5) The number of votes given at each precinct to each person, and for and against each measure; and 6) The total number of votes given to each person, and for and against each measure. (Exhibit "A")

Section 7. That the City Clerk did on November 24, 1992, and pursuant to City Charter Section 153, make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk did also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

Section 8. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.

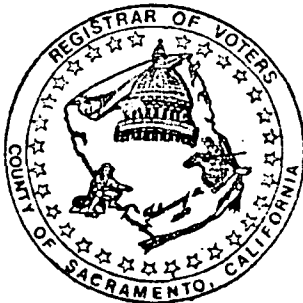
