SUMMARY

The contract for the Renfree Field food concession expired on December 31, 1981. A bid has been received, and it is necessary to award a contract.

BACKGROUND INFORMATION

On October 27, 1981, the City Council called for bids to be received on November 28, 1981. No bids were received. Interested bidders later contacted the department, and on February 16, 1982, the City Council called for bids to be received on March 9, 1982.

The City Clerk received one (1) bid on March 9, 1982, by Raymond Ebbitt and Margaret Ebbitt with a contract fee of seven (7) percent of the gross receipts.

FINANCIAL DATA

For comparison, the expired contract with Mr. and Mrs. Ebbitt provided 7.00% of gross receipts for the City.

RECOMMENDATION

It has been determined that the bidder, Mr. and Mrs. Ebbitt, is in compliance with all the requirements of the City. Pursuant to

the provisions of Chapter 12, Article III, of the City Code, it is recommended that the City Council award the concession contract to Mr. and Mrs. Ebbitt at a contract fee of 7.00% of the gross receipts of the Renfree Field food concession in Del Paso Park.
