SUBJECT: Extension of an Agreement for Elderly Nutrition

Program at Sim Community Center

### SUMMARY

The Sacramento Area Economic Opportunity Council desires to continue a lunchtime nutrition program for the elderly at the Sim Community Center on a Monday through Friday basis.

#### BACKGROUND INFORMATION

SAEOC has conducted noontime nutrition programs available to senior citizens in the area of Sim Park for a number of years. The only public facility in the area capable of handling the service is the Sim Community Center.

The staff has reviewed the proposed program and recommends that according to the terms of the current agreement, the option of extending the agreement for one year, which shall be July 1, 1981 through June 30, 1982 be adopted.

# FINANCIAL DATA

The nutrition program will create no additional cost to the City. The City will make the facility available and SAEOC will provide the labor and material required to carry out the program.
