**SUBJECT:** Revocable Encroachment Permit - Roger and Marie Valine

The encroachment area is described as follows:

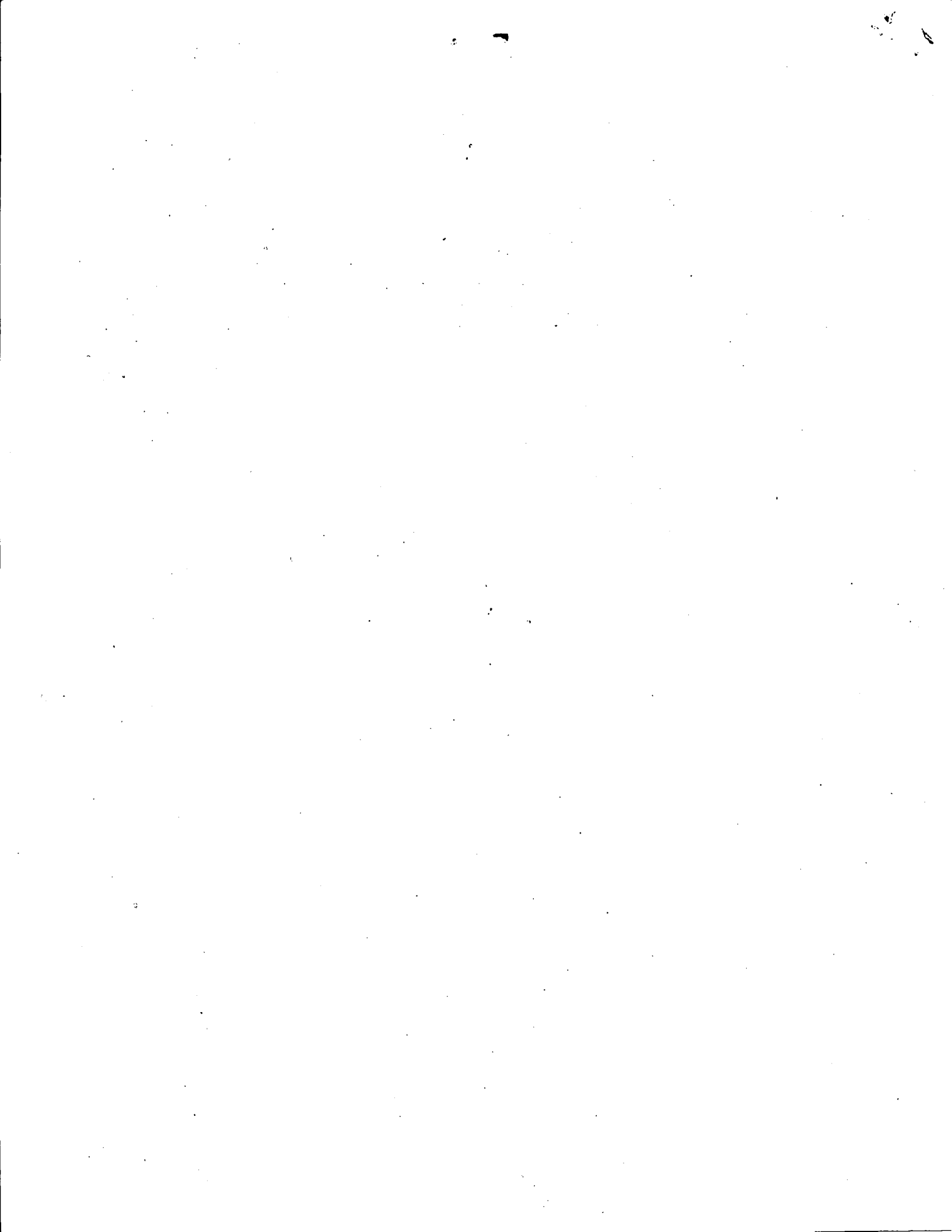
An area west of 201 Delta Oaks Way. An Area approximately 40' x 300' or 1200 square feet.
