SUBJECT: Resolution Approving Negative Declaration for ACQUISITION AND DEVELOPMENT OF CAMELLIA SCHOOL PARK

#### SUMMARY

The Environmental Coordinator has reviewed the subject project and finds that it will not have a significant adverse effect on the physical environment and therefore recommends that the project and a Negative Declaration be approved by the City Council.

### BACKGROUND

In accordance with State EIR Guidelines for Implementation of the California Environmental Quality Act of 1970, dated December 1976, an Initial Study was performed. As a result of this study, it was determined that the ACQUISITION AND DEVELOPMENT OF CAMELLIA SCHOOL PARK would not have a significant adverse effect on the physical environment and a draft Negative Declaration was prepared. On January 22, 1980, the Negative Declaration was filed with the County Clerk. On January 24, 1980, Notice of Opportunity for Public Review of the draft Negative Declaration was published in The Sacramento Union. The appropriate length of time has elapsed for receipt of comments regarding the Negative Declaration, with no comments having been received.

#### RECOMMENDATION

The Environmental Coordinator recommends that the attached resolution be passed which will:

- Determine that the proposed project will not have a significant effect on the 1. environment.
- 2. Approve the Negative Declaration.
- Approve the project. 3.
- Authorize the Environmental Coordinator to file a Notice of Determination with 4. the County Clerk.
