

ORDINANCE NO. 1048, FOURTH SERIES.

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 1036, FOURTH SERIES, PASSED JANUARY 26, 1945, AND ENTITLED: "AN ORDINANCE RELATING TO TRAFFIC AND REGULATING THE USE OF PUBLIC STREETS IN THE CITY OF SACRAMENTO; DEFINING AND PROVIDING FOR THE ESTABLISHMENT OF PARKING METER ZONES; REGULATING AND CONTROLLING AND PROVIDING FOR INSPECTION OF THE PARKING OF VEHICLES THEREIN BY THE USE OF PARKING METERS; PRESCRIBING LIMITS OF TIME FOR PARKING IN PARKING METER ZONES; PROVIDING FOR THE ENFORCEMENT OF THIS ORDINANCE AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF," AND MAKING THIS ORDINANCE AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF
SACRAMENTO:

SECTION 1: Section 2 of Ordinance No. 1036, Fourth Series, passed January 26, 1945, is hereby amended to read as follows:

Section 2: The following area within the City of Sacramento is hereby established as a parking meter zone:

"I" Street from 6th Street to 10th Street;
"J" Street from 5th Street to 14th Street;
"K" Street from 4th Street to 14th Street;
"L" Street from 6th Street to 13th Street;
Fifth Street from "J" Street to "K" Street;
Sixth Street from "J" Street to "L" Street;
Seventh Street from "I" Street to "L" Street;
Eighth Street from "I" Street to "L" Street;
Ninth Street from "I" Street to Capitol Avenue;
Tenth Street from "I" Street to Capitol Avenue;
Eleventh Street from "I" Street to "L" Street;
Twelfth Street from "I" Street to "L" Street;
Thirteenth Street from "J" Street to "L" Street;
Fourteenth Street from "J" Street to "K" Street;
California Street from 5th Street to 8th Street.


SECTION 2: This ordinance is hereby declared to be an emergency measure and shall take effect immediately; such emergency being that the orderly enforcement of the parking laws within the parking meter area requires that the above mentioned streets be included within the parking meter zone at the time that the operation of the parking meters is begun.
