SUBJECT: Sutter West Business Center - Consultant Services Agreement

SUMMARY

It is requested that an agreement be entered into with Murray Smith and Associates, Inc., for the Sutter West Business Center, located at the southwest quadrant of Northgate Boulevard and I-80 on Rosin Court.

BACKGROUND

Presented for approval is a Consultant Services Agreement in the amount of \$45,500 with Murray Smith and Associates, Inc., to prepare all improvement drawings for all works of improvements within the City rights-of-way for Sutter West Business Center. The work shall specifically include geometrics and design of streets, sewers, sewer lift station, drains, curbs and gutters, and water. Also included will be right-of-way descriptions and plats. Excluded from the work is the electrical and street lighting, gas, telephone and construction staking.

FINANCIAL

There is no net cost to the City incurred by this agreement. Sufficient fees have been collected to cover all consultant costs and are available within the Engineering Division's budget.
