4. Board Orientation & Strategic Planning of DAC activities

Staff facilitated discussion and sought commitment and approval from the Commissioners to conduct Board Orientation & Strategic Planning of DAC activities. Staff identified three areas of training that would be important for a better functioning of DAC as they carry out their duties. The three areas of focus presented to the Commissioners were the Brown Act requirements, Board Orientation and Strategic planning and the Overview of the Americans with Disabilities Act (ADA).

Staff answered questions from the Commissioners relative the reasons for these sought actions and the logical order of the suggested training. It was decided to start the first workshop, with the general requirements of the Brown Act, and the Overview of the Americans with Disabilities Act (ADA) scheduled for September 10, 2007. The Board Orientation and Strategic planning was scheduled for September 20, 2007.

The Brown Act would be facilitated by Staff from the City Clerks Office, the ADA overview by staff from City Equal Opportunity / ADA office and the Strategic Planning by City Organization Office.

Commissioner Thom made the motion to approve the staff recommendation and to set up dates for the training / workshop. Commissioner Kysor seconded. Motion passed.

5. Administrative Requirements under Title II of the ADA

Staff, Michael paravagna reported on the recent development of the ADA public notice, ADA complaints and grievance procedure on the public City ADA website, and encouraged the Commissioners to visit the website.

6. City Disability Awareness Event

Staff announced that the Equal opportunity Division was contemplating hosting a Disability Awareness Fair on October 4, 2007 to be held at the City Hall Plaza location. The Commissioners commitment, participation were sought. Staff answered questions from the Commissioners relative the reasons for the event. Mr. Paravagna, the City ADA Coordinator stated the need for the DAC and Disability issues to be visible, and to have City employees start to think about different kinds of disabilities.

Commissioner Thom made the motion to approve having the event and for DAC to a have a table at the Disability Awareness Fair. Seconded by Commissioner Kysor. MSP
