SUBJECT: Approval of Parcel Map Agreement (P-8471)

BACKGOUND INFORMATION

On August 21, 1979, the Council adopted Resolution No. 79-582 which approved a tentative parcel map for Parcel Map 56 and 57 for property owned by Dave Dodson and Alice Dodson. A condition of approval of this tentative map was that the Dodsons enter into an agreement with the City to participate in and assist in the formation of any proposed assessment district which might be formed to construct improvements involving their property. This agreement is being presented for approval at this Council meeting.
