SUMMARY

The reconstruction of Grove Avenue from Del Paso Boulevard to Eleanor Avenue is eligible for Federal Combined Roadway Program (CRP) funding. The attached program supplement reserves CRP funding at 85.87% of approved items of work, in an amount of \$1,121,853. The City will provide the matching 14.13% of the approved project costs and all overhead costs. Approval of the attached program supplement and the appropriation of additional City funds to advertise the project is recommended. It is also recommended that this item be forwarded to the City Council for approval.

BACKGROUND

This project will reconstruct Grove Avenue between Del Paso Boulevard and Eleanor Avenue. The proposed work includes the construction of a new roadway pavement section, curb, gutter and sidewalk, an underground drainage system, replacement of existing water and sewer services, construction of a street lighting system and the relocation of existing traffic signals and related appurtenances.

Federal funding will provide for 85.87% of approved project costs, the City will provide the matching 14.13% of the approved project costs and all overhead costs.

The attached Program Supplement No. 041 to Local Agency - State Agreement No. 03-5002 provides for Federal reimbursement of construction

contract and construction engineering costs for this project. Preliminary engineering funds were previously programmed.

Approval of the attached program supplement and the appropriation of Capital Grant funds in the amount of \$1,044,570 and transfer of additional City funds in the amount of \$40,000 is recommended.

FINANCIAL DATA

The estimated total project cost, including all planning, design and construction costs, is \$1,391,200. The current budget is \$227,283, which was approved in the Capital Improvement Program with \$150,000 from Major Street Construction Funds (209), and \$77,283 from Capital Grants Funds (248) originating from Federal Combined Roadway Program (CRP) funds. In addition, at its meeting of May 7, 1991, the Budget and Finance Committee forwarded to the City Council for approval, the appropriation of an additional \$96,500 to the project from the sale of Federal CRP funds. This will bring the total project budget to \$323,783.

Additional funds in an amount of \$1,084,570 are proposed to be added to the project budget at this time, bringing the total budgeted amount to \$1,408,353. It is proposed that the funds be allocated as follows:

Fund Transfer from Miscellaneous Sewer Improvements (Fund 414, PN:XB16)	\$ 40,000
Capital Grant Fund - Federal CRP (Fund 248)	<u>1,044,570</u>
TOTAL	\$1,084,570

The CRP will provide funds to cover 85.87% of approved project costs and a program supplement is currently being processed to provide an additional \$1,044,570, which will be appropriated to the project as Capital Grants funds (248). To fund the City's 14.13% share plus overhead costs, an additional \$40,000 is needed. It is proposed that this \$40,000 be transferred from the Miscellaneous Sewer Improvements project (Fund 414, PN:XB16) which had a balance of \$110,000 as of May 1, 1991.





SPECIAL COVENANTS OR REMARKS

1. All maintenance, involving the physical condition and the operation of the improvements, referred to in Article VI MAINTENANCE of the aforementioned Master Agreement will be performed by the Local Agency at regular intervals or as required for efficient operation of the completed improvements.
2. The Local Agency will advertise, award, and administer this project and will obtain the State's concurrence prior to either award or rejection of the contract.
3. The Local Agency will furnish a qualified Resident Engineer for the contract.
4. The Local Agency will reimburse the State for their share of costs for work requested to be performed by the State.
5. The Local Agency agrees the payment of Federal funds will be limited to the amounts approved by the Federal Highway Administration in the Federal-Aid Project Agreement (PR-2)/Detail Estimate, or its modification (PR-2A) or the FNM-76, and accepts any increases in Local Agency Funds as shown on the Finance or Bid Letter or its modification as prepared by the Division of Local Streets and Roads.
6. The dollar value difference between the amount shown in the "Federal Funds" field and the amount certified on page one of this Program Supplement shall be automatically funded when sufficient funds are made available upon approval of the Annual State Budget.
7. In executing this Program Supplemental Agreement, Local Agency hereby reaffirms the "Nondiscrimination Assurances" contained in the aforementioned Master Agreement for Federal-Aid Program.
8. Whenever the local agency uses a consultant on a cost plus basis, the local agency is required to submit a post audit report covering the allowability of cost payments for each individual consultant or sub-contractor incurring over \$25,000 on the project. The audit report must state the applicable cost principles utilized by the auditor in determining allowable costs as referenced in CFR 49, part 18, Subpart C - 22, Allowable Costs.
