Title: Contract: Purchase of One Roadway Striper

Recommendation: Adopt a **Resolution** awarding a contract to Western Truck Parts and Equipment, the lowest responsible and responsive bidder, for the purchase of one Roadway Striper in an amount not to exceed \$207,319.

Description/Analysis

Issue: The Street Services Division, Traffic Signs and Markings section has a need to purchase one roadway striper. This vehicle will replace an older, non-functioning striper and will be used for various maintenance and construction tasks throughout the City of Sacramento

Policy Considerations: The recommendations in this report are in accordance with the provisions of the City Code Section 3.56 and are consistent with the City's Strategic Plan goals to improve and expand public safety, and achieve sustainability and livability.


Environmental Considerations: The Environmental Services Manager has determined that the action of purchasing vehicles does not have the potential for causing a significant effect on the environment and is therefore exempt under California Environmental Quality Act (CEQA) Guideline, Categorical Exemption Section 15061(b)(3).


Commission/Committee Action: Not Applicable


Rationale for Recommendation: In May 2007, Procurement Services sent out Invitation for Bid No. B071181088, which was developed and administered in accordance with City Code Section 3.56 for the purchase of a roadway striper for use by the Department of Transportation, Street Services Division, Traffic Signs and Markings section. The new unit will replace a unit that was 22 years old and beyond repair. Nineteen (19) vehicle manufacturers were solicited, four bids were received, and Western Truck Parts was determined to be the lowest responsible bidder.

Financial Considerations: Sufficient funds are available for this purchase in the FY2006/07 Street Services and Fleet Management operating budgets.

Emerging Small Business Development (ESBD): Western Truck Parts and Equipment is not certified with the City as an emerging or small business enterprise. There are no known ESBE firms in this market.

AWARDING CONTRACT: PURCHASE ONE ROADWAY STRIPER

BACKGROUND

- A. The Department of Transportation, Street Services Division, Traffic Signs and Marking section, has a need for one roadway striper. The current striper was purchased used and is currently non-operational. It is not repairable at a reasonable cost for the age of the equipment (twenty-two years).
- B. In May, 2007, the City issued a formal Invitation to Bid (B0711811008) for one roadway striper. Three bidders responded. The lowest responsible and responsive bidder was Western Truck Parts and Equipment.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. Award a contract to Western Truck Parts and Equipment, 1441 Richards Boulevard, Sacramento, CA 95814, the lowest responsible and responsive bidder, for the purchase of one Roadway Striper in an amount not to exceed \$207,319.
