Subject: Resolution of Intent Regarding Future Use of Fire Station No. 4

Location/Council District: Citywide

Recommendation:

This report transmits for Council consideration and action a RESOLUTION of intent that 1) when Fire Station No. 4 is no longer needed by the City of Sacramento, the Council will give first consideration to leasing Fire Station No. 4 to the Pioneer Mutual Hook and Ladder Society for a nominal sum on the condition that Fire Station No. 4 will be used as a museum and open to the public and 2) that at such time that lease negotiations with Pioneer Mutual Hook and Ladder Society for use of Fire Station No. 4 occur or thereafter, that use of the drill tower and utility shop will also be considered for inclusion in the lease, at such time that these facilities become surplus to the City's needs.

Description/Analysis:

Issue: The Pioneer Mutual Hook and Ladder Society has indicated an interest in using Fire Station No. 4 located at 3145 Granada Way as a fire museum with storage, as well as the drill tower and utility shop located at 3230 J Street for equipment demonstration and a restoration facility.

City Code only allows the conveyance of real property without consideration when for a public purpose to a public body or agency. However, City Code does allow the City to lease city property for a nominal sum when it is for a public

purpose and the City Council determines it is in the best interest of the City to do so.

This report transmits a resolution indicating the Council's intent that when Fire Station No. 4 is no longer needed by the City of Sacramento, the Council give first consideration to leasing Fire Station No. 4 to the Pioneer Mutual Hook and Ladder Society for a nominal sum on the condition that it be used as a museum and open to the public. The resolution also provides that at such time that lease negotiations with Pioneer Mutual Hook and Ladder Society for use of Fire Station No. 4 occur or thereafter, that use of the drill tower and utility shop will also be considered for inclusion in the lease, at such time that these facilities become surplus to the City's needs.


Policy Considerations: Negotiations with PMHLS would occur at such time that Fire Station No. 4 is no longer needed by the City of Sacramento.

Environmental Considerations: This is not defined as a project under the California Environmental Quality Act (CEQA), and, therefore, is exempt.

**RESOLUTION OF INTENT REGARDING
FUTURE USE OF FIRE STATION No. 4**

BACKGROUND

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

Section 1: The City Council intends that when Fire Station No. 4 is no longer needed by the City of Sacramento, the Council will give first consideration to leasing Fire Station No. 4 to the Pioneer Mutual Hook and Ladder Society for a nominal sum on the condition that Fire Station No. 4 will be used as a museum and open to the public.

Section 2: The City Council also intends that at such time that lease negotiations with Pioneer Mutual Hook and Ladder Society for use of Fire Station No. 4 occur or thereafter, that use of the drill tower and utility shop will also be considered for inclusion in the lease, at such time that these facilities become surplus to the City's needs.
