SUBJECT: TRANSFER OF FUNDS FROM SOLID WASTE CONTINGENCY

SUMMARY



SUBJECT: TRANSFER OF FUNDS FROM SOLID WASTE CONTINGENCY

SUMMARY

This report requests the City Council's Budget and Finance Committee's approval of the transfer of \$148,000 from the Solid Waste Fund Contingency Reserves for the purpose of starting construction and installation of the washrack at the 28th Street Yard.

BACKGROUND

The present washrack located at the 28th Street Yard is totally inadequate to maintain the various pieces of refuse collection and garden refuse equipment in a clean and health-safe condition. On several occasions, the County Health Department has cited the Solid Waste Division for violations related to the lack of cleanliness of the refuse packer vehicles.

The washrack has gone through several design updates over the past few years with the most current design including a bin cleaning facility along with the high pressure washrack. These design changes have continuously escalated the cost of the facility. Based on the bids received April 21, 1987, and design, inspection and contingency costs, \$148,000 will be needed for this project. Prior to receiving bids, the Solid Waste Division estimated the cost to be \$152,000. This amount was submitted in the 1987-1992 CIP process for funding in FY 1987-88.

FINANCIAL DATA

This project went out for bid: bids have been received for the construction and installation of the washrack. Due to the timing of the bids, it is requested that the CIP project be moved up in order to start on the project during the 1986-87 (current) fiscal year. This would require transferring \$148,000 from the Solid Waste Fund Contingency Reserves to the CIP Fund.



A RESOLUTION AMENDING THE CITY BUDGET FOR FY 86-87

1. The City budget for Fiscal Year 1986-87 is hereby amended by transferring \$148,000 from the Solid Waste Contingency Reserves Fund 415-710-7012-4999 to the Washrack Project (4-15-500-YA56-4820).
2. The proposed Washrack Upgrade project be deleted from the 1987-92 CIP Program priorities as approved by City Council on April 7, 1987.
