SUBJECT: PROGRAM SUPPLEMENT NO. 20 TO LOCAL AGENCY-STATE AGREEMENT NO. 03-5002  
COVERING SOUTHERN PACIFIC TRANSPORTATION COMPANY'S RAILROAD CROSSING  
AT 24TH AVENUE

### SUMMARY

Attached is Program Supplement No. 20 to Local Agency-State Agreement No. 03-5002 covering Federal Aid Safety Improvement Project No. RRP 0067(011), Southern Pacific Transportation Company Railroad Crossing at 24th Avenue. The City Engineer recommends that this agreement be approved and the City Manager and City Clerk be authorized to execute the agreement.

### BACKGROUND

On July 5, 1977, the City of Sacramento entered into Agreement No. 03-5002 with the State of California, Department of Transportation, under which the City and State agree to the terms and conditions outlined by the Congress of the United States for expenditure of Federal Aid Funds administered by the State. Subsequent program supplement agreements are required for each project to be constructed under this program. Program Supplement No. 20 covers placing gates at the Southern Pacific Transportation Company's Railroad Crossing at 24th Avenue.

### FINANCIAL DATA

As indicated on Exhibit B of the agreement, this project is estimated to cost \$85,250. It is estimated that the City's share of the project is \$8,525. Funds are available in the 1980-81 budget from Misc. Gas Tax funds.

### RECOMMENDATION

The City Engineer recommends that the attached resolution be approved authorizing the City Manager and the City Clerk to execute Program Supplement No. 20.
