- I. The meeting was called to order at 3:37 p.m. W. Ceccherelli advised Committee that Diana Walker-Smith will be assisting with the APP Program until a permanent administrator is hired in January or February, 1992. She also advised Committee that the nominations of Kim Scott and Jack Nielsen are on the Commission November 13 agenda for approval. Ceccherelli addressed the policy regarding Committee member terms, and said that the policy was consistent for all committees. No Committee members are guaranteed reappointment every year, but may serve up to 3 years.

- a. Weinstock's (Sam Francis painting) - Attorney for Carter, Hawley, Hale (owners of Weinstock's) wish to remodel their K Street store, and have requested the Arts Commission to advise them in writing that Weinstock's owns the artwork and may remove it at their discretion.
