**SUBJECT:** Metropolitan Arts Division - Authorization to Submit Grant Application under the California Arts Council's Technical Assistance Program.

### SUMMARY

This report recommends authorization for the Metropolitan Arts Division to submit a grant application to the California Arts Council in the amount of THIRTY-FIVE THOUSAND DOLLARS (\$35,000) for the purpose of conducting a technical assistance program to begin January 1981 through December 1981.

### BACKGROUND

In 1978-79 and 1979-80, the Sacramento Metropolitan Arts Commission received contracts from the California Arts Council to conduct a regional technical assistance program. The 1981 program is designed to expand current workshops, present a Fall conference, and develop a resource and training center in arts management.

### FINANCIAL DATA

The grant does not require additional City or County funds. However, a 50/50 match is required in funds other than State monies. The Metropolitan Arts Division intends to match the grant amount with earned income and National Endowment for the Arts funds.


