SUBJECT: Resolution Authorizing Execution of Agreement Between Brown and

Caldwell and the City of Sacramento for the Preparation of a

Drainage Study for North Sacramento Area "B"

## SUMMARY:

Presented herewith for approval is a consultant services agreement for an amount not to exceed \$41,400 between Brown and Caldwell and the City of Sacramento for the preparation of a drainage study for North Sacramento Area "B" (see attached map).

#### BACKGROUND:

This agreement is presented to conform to the guidelines of the policy for Retention of Professional Consultants for City Projects adopted February 26, 1980. The charges shall represent hourly charges for personnel involved in the work, materials, supplies, stakes, mileage and prints needed in the work process, with the total fee not to exceed \$41,400.

The subject area presently has a very inadequate drainage system that has been constructed on a piecemeal basis over the years. The subject study will identify a drainage system with suggested phasing to eliminate the drainage problems.

## FINANCIAL:

The 1980/81 budget includes \$175,000 from Sewer Funds for the drainage studies for areas A and B.

It is recommended that the City Manager and City Clerk be authorized to execute the


