SUBJECT: Resolutions Continuing Salaries and Benefits Pursuant to the Current Agreements with American Federation of State, County and Municipal Employees (AFSCME), Local 146 and the Sacramento Housing and Redevelopment Agency Employees' Association (SHRAEA), beyond the expiration date of December 18, 1987

SUMMARY

The agreements between American Federation of State, County and Municipal Employees, Local 146 and the Sacramento Housing and Redevelopment Agency Employees' Association expire on December 18, 1987. Therefore, since new agreements cannot be reached and approved by December 18, 1987, it is requested that salaries and benefits pursuant to the current agreements be continued. In the event agreement is reached by December 18, 1987, staff will return to the Governing Board in January, 1988 with the agreements which will be retroactive to December 19, 1987.

RECOMMENDATION

The staff recommends that the Housing Authority and Redevelopment Agency of the City of Sacramento adopt the attached resolutions which extend the provisions of the current agreements with AFSCME, Local 146 and SHRAEA beyond the term which expires on December 18, 1987.

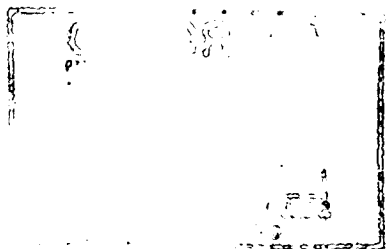
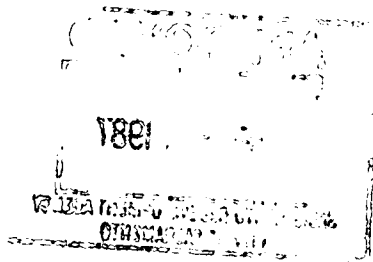
