SUMMARY:

Agency staff recommends adoption of the attached resolution amending the Agency's 1989 budget to add three Homeless Specialist I positions to the Homeless Programs' Division of the Community Development Department.

BACKGROUND:

At the time the decision was made to fund the In-Kind Services Program for County General Assistance recipients, funding was provided for two Homeless Specialist I positions within the Agency. In addition, a limited term Homeless position was approved for implementation of the emergency shelter components provided in conjunction with the American River Parkway camping problem.

When the decision was made to carry out the implementation of those programs the Agency budget was not properly awarded to include these positions. The attached resolution rectifies this situation.

FINANCIAL:

The cost of the 3 additional positions will be funded from the County's Aid In-Kind Funds.


RECOMMENDATION:
