
SUMMARY

Attached is a tabulation of sealed proposals received by the City Clerk for furnishing equipment in accordance with the specifications used in the bidding process, and recommendation of bid award for Bid No. 1605 for Skid Steer Loaders/Tractors, being purchased by Fleet Management Division for various City organizations.

BACKGROUND

Specifications for Bid No. 1605 were advertised and mailed by the City Clerk, with mailing to vendors, bid advertising firms, and minority outreach agencies, beginning on March 31, 1993. Sealed bids were publicly opened by the City Clerk on April 21, 1993.

FINANCIAL CONSIDERATIONS

Sufficient funds for these purchases are available in the Fleet Management Division's budget lines 4631 and 4632 for replacement and new vehicles.

POLICY CONSIDERATIONS

This recommendation is consistent with the requirements for competitive bidding as detailed in Chapter 57 of the Sacramento City Code.

MBE/WBE EFFORTS

Requests for bid (RFB) were sent to sixteen vendors, two of which are M/WBE firms. The names of the M/WBEs were obtained from the City bid list and by researching the EBMUD Minority and Women Business Enterprise 1992-93 Directory, the Human Rights Commission MBE/WBE Directory and the State of California - Winter 1993 Disadvantaged Business (DB) and Woman Business Enterprise (WBE) List. In addition, the RFB was sent to several bid advertising agencies, including the Minority Business Exchange and the Sacramento Minority Business Development Center. No responses were received from M/WBE firms.
