SUBJECT: Sacramento Boat Harbor - Berth License Fee Increase

SUMMARY

This report recommends a berth license fee increase at the Sacramento Boat Harbor effective October 1, 1980. The fee increase is related to capital improvements at the Boat Harbor and was approved by the Budget and Finance and Planning and Community Development Committees at a joint meeting on August 4, 1980.

BACKGROUND INFORMATION

The Budget and Finance Committee and Planning and Community Development Committee, acting jointly, reviewed a number of reports submitted by the staff concerning the revenue/expenditures of the Sacramento Boat Harbor enterprise for FY 80-81. The reports reviewed included a survey of Boat Harbor patrons' capital improvement preferences and a documentation of opinions on a fee increase to support the annual maintenance and operation of the Harbor and to implement the first year of basic level capital improvements to the Harbor.

The Committee deleted all capital improvements that would increase the basic service level to Harbor patrons. These included a secure parking lot, dock storage lockers, a restroom and shower building, and improvements to the Harbor office.

FINANCIAL DATA

The last fee increase was imposed in June of 1978 and since that time the following inflationary trends has taken place:

A berth license fee increase of 21.7% for covered berths and a 20.7% for open berths will produce sufficient revenues for FY 1980-81 to support the Harbor enterprise operation.

Exhibit A provides a marina rate comparative survey which reflects the Sacramento Boat Harbor existing and proposed fees.

RECOMMENDATION

It is recommended that the City Council approve the following:

1. By resolution, approve a berth license fee increase effective October 1, 1980 as follows:

| Covered Berths | \$2.30/ft. | \$2.80/ft. |
| Open Berths | \$1.45/ft. | \$1.75/ft. |

The fee increase will provide funds for the Boat Harbor maintenance and operation budget and for Basic Level Capital Improvements to the Harbor.

2. Direct the staff to prepare an annual review of the Boat Harbor license fees as part of the budgetary process. The intent of this action is to make the major revenue source, berth license fees, responsive to the annual expenditures of this enterprise operation.
