SUMMARY

Attached is an amendment to the existing agreement with the Elk Grove School District which provides that all school impaction fees shall be impounded until the issue of legality of the fees is settled.

DISCUSSION

On December 9, 1980, the Council by ordinance extended Chapter 67 of the City Code relating to school impaction. At that time it was recommended by this office that the existing agreement with the Elk Grove School District for the impoundment of school impaction fees be amended to impound all fees collected, not just fees in excess of those levied prior to the passage of The Council will recall that the basis for this Proposition 13. recommendation was the concern of this office that school impaction fees might be held to be special taxes under Proposition 13. The amendment to the agreement has been executed by the Superintendent of the Elk Grove School District and is now before the Council for approval.

RECOMMENDATION

It is recommended that the Council by resolution authorize the City Manager to execute the attached amendment to the agreement with the Elk Grove School APPROVIDE AG- 80165
