SUBJECT: Citation Authority for Public Works Classifications

SUMMARY

The attached resolution amends Resolution #86-404, which specifies employees within the Public Works Department to be granted citation authority pursuant to Ordinance #85-033. Adoption of the resolution is necessary due to personnel changes.

BACKGROUND

Prior to passage of Ordinance #85-033, certain City employees were designated "Special Police Officers" by the City Manager in order to grant them citation issuance authority. Classifications within the Parking Division, Animal Control Division and Solid Waste Division were included in the "Special Police Officer" designation. Due to confusion, which arose between the "Special Police Officer" and Peace Officer status under the Penal Code, Ordinance #85-033 was drafted to change the way in which citation authority was granted.


The ordinance eliminated "Special Police Officer" status and specified that the City Manager submit to the City Council a list of persons within the classification to be granted citation authority. The Council would then grant the authority by resolution.


RECOMMEDATION:

RESOLUTION AMENDING RESOLUTION
NO. 86-404 GRANTING CITATION AND
ARREST AUTHORITY TO CERTAIN
