


Gay Pride Parades

- Freedom Fair at Southside Park







- Developed boundary



Lavender Heights Historic District

- Variety of buildings with different uses important to LGBTQ+ community life
- 12 contributors:
 - Lambda Community Center (1931 L Street and 919 20th Street)
 - The Mercantile Saloon (1928 L Street)
 - Faces/K Street Station (2000 K Street)
 - The Western/The Depot (2001 K Street)
 - Sacramento Women's Center/Gifted Gardener (2220 J Street)
 - First Sacramento Women's Building (2224 J Street)
 - Dr. Harvey Thompson and Dr. Sandy Pomerantz offices / The Open Book (912 21st Street)
 - First United Methodist Church(2100 J Street)
 - Sacramento AIDS Foundation
 - 2115 J Street (1985)
 - 1900 K Street (1986-1994)
 - New Helvetia Roaster (1215 19th Street)













Lavender Heights Historic District

Historically significant group of cultural landmarks associated with the development of a visible LGBTQ+ community in Sacramento, starting in 1967 through the year 2000, when increasing integration of the LGBTQ+ community into mainstream society resulted in distinct changes to the tight-knit character of the community.













Individual Historic Landmarks


- Protect and highlight places important to LGBTQ+ history
- 5 nominated to Sacramento Register now as part of grant
- More can be nominated

Methodology

 Research (oral histories, books, dissertations, newspaper articles, etc.)

How were properties selected?

- Not already landmarked
- Represent variety of uses and neighborhoods
- Do they survive?
- Do they have integrity? (Are they recognizable?)



1. Alternative Coffee Shop (2215 P Street)

- Coffeeshop created in 1971 as a space for young gay people to socialize outside the gay bar scene.
- Located in apartment of Edgar, possibly Edgar Carpenter, founding member of the Society of Homosexual Freedom and Gay Studies Program at Sac State
- Site of early SHF meetings and gay potluck dinners



2. Bo Jangles (7042 Folsom Boulevard)

- First bar opened by Terry Sidie in Sacramento in 1976.
- Opened just after repeal of California anti-sodomy laws in 1975. Few bars in Sacramento at the time.
- Important early social gathering place in Sacramento City for people to be publicly out and meet others like them.



3. Incredible Edible Place (1401 Alhambra Boulevard)

- Restaurant opened by Paul Fitzgerald in 1977.
- Also opened the Upstairs Downstairs bar downtown.
- Coined name of "Faces."
- Openly employed and served a mix of gay and straight patrons.
- Open late to provide early social alternative to bar scene for LGBTQ+ community.
- Site of early meetings of LGBTQ+ groups, including the Advocates for Gay State Employees (AGSE), River City Democratic Club.



4. Mom Guess What...! Offices (1725 L Street)

- Site of MGW offices from ca. 1988-2003 (15 years), the paper's longest known location.
- Newspaper for LGBTQ+ community and allies founded by Linda Birner that ran from 1978-2009.
- Covered important LGBTQ+ legislation, local news, arts and entertainment, calendar or social events, and more
- Important for connecting community members.



5. The Blue Moon (2565 Franklin Boulevard)

- Popular women's bar owned by Shannon Morgan from ca. 1985-1990
- Popular gathering spot for women's sports teams (softball, rugby)
- Site of first Ms. Leather Sacramento competitions (1987-1990)
