You are welcomed and encouraged to participate in this meeting. Public comment is taken (3 minutes maximum) on items listed on the agenda when they are called. Public Comment on items not listed on the agenda will be heard at the end of the meeting as noted on the agenda. Comments on controversial items may be limited and large groups are encouraged to select 3-5 speakers to represent the opinion of the group.

Notice to Lobbyists: When addressing the Committee you must identify yourself as a lobbyist and announce the client/business/organization you are representing (City Code 2 15 160).

Speaker slips are located in the rack inside the chamber and should be completed and submitted to the City Clerk.

Government Code 54950 (The Brown Act) requires that a brief description of each item to be transacted or discussed be posted at least 72 hours prior to a regular meeting. The City posts Agendas at City Hall as well as offsite meeting locations. The order of Agenda items are listed for reference and may be taken in any order deemed appropriate by the legislative body. The Agenda provides a general description and staff recommendations; however, the legislative body may take action other than what is recommended. Full staff reports are available for public review on the City's website and include all attachments and exhibits. "To Be Delivered" and "Supplemental" reports will be published as they are received. 3. **Review of Campaign Finance (Oral Report)**

Location: Citywide

Recommendation: Provide direction and possible action to staff regarding review of the City's Campaign Finance Ordinances.

ACTION: The Committee gave general direction to staff including: 1) simplify and clarify ordinance language to make it easier to understand, 2) look at ethics commission possibilities and what other cities are doing in this area as well as campaign finance reporting; 3) look at the legality of how to recuperate matching funds that were used when one of the 8 principles is violated; 4) investigate if anyone has been elected using matching funds or defeated an incumbent using matching funds, at the local level; 5) look at independent expenditures.

4. Interim Ordinance Relating to Tethered Inflatables for Model Home Complexes

Location: Citywide

Recommendation: Staff recommends the Law and Legislation Committee recommend approval of the interim ordinance to allow tethered inflatables for model home complexes and forward to City Council

5. Legislative Position: Support Senate Bill 266 Relating to Forfeiture of Motor Vehicles Involved in Motor Vehicle Speed Contests.

Recommendation: Staff recommends the Law and Legislation Committee adopt a support position on SB 266, which would permit cities and counties to adopt ordinances, declaring that vehicles involved in motor vehicle speed contests are public nuisances subject to forfeiture.
