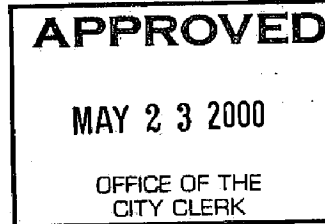

**SUBJECT: 12TH STREET MAINTENANCE DISTRICT BUDGET FOR FY 2000/01 IN THE AMOUNT OF \$17,666**

**LOCATION AND COUNCIL DISTRICT:**

The 12th Street Maintenance District is located in Council District 1. The district includes properties adjacent to 12th Street from "C" Street to "I" Street, as shown on Attachment A.

**RECOMMENDATION:**

The report recommends that the City Council adopt the attached resolution adopting the FY 2000/01 12th Street Maintenance District fees and amending the FY 2000/01 operating budget for district related expenses.

**SUMMARY:**

This report contains the budget for the 12th Street Maintenance District for FY 2000/01. Services include street sweeping of gutters and pedestrian sidewalks, and landscaping maintenance. There is no increase in the annual assessment. The fees necessary to implement the budget represent a full recovery of costs for this district and are indicated on Exhibit B of the attached resolution.

**BACKGROUND INFORMATION:**

On April 3, 1990, City Council adopted Resolution No. 90-245 approving the formation of the 12th Street Maintenance District. The maintenance services provided include street sweeping of gutters and pedestrian sidewalks, and landscape maintenance. The district pays for maintenance services which are above and beyond the level of normal City service.

The current district includes 37 commercial parcels within a seven service block area along 12th Street.

Annually, the City Council is requested to:

- Determine the costs for the additional services provided;
- Determine whether the costs of the additional services shall be borne wholly or partially by the property owners within the area; and
- Affix a service fee to be charged to cover the costs to be borne by each property owner within the area.

**FINANCIAL CONSIDERATIONS:**

The fees levied are used to defray additional City and contractor expenses associated with the higher level of maintenance services provided in this area. The proposed expenditures are fully fee supported.

The total cost of the 12th Street Maintenance District for FY 2000/01 is \$17,666 (see attached resolution). The total amount assessed to the property owners is \$4,862 (\$17,666 less a surplus fund balance of \$12,804). The fees are assessed by front footage. The proposed budget will require assessments which are equal to the FY assessments. The annual fee for a typical 80-foot wide lot is \$118. The fees recommended represent a full recovery of costs from the property owners.

**ENVIRONMENTAL CONSIDERATION:**

Under CEQA guidelines, continuing administration and annual maintenance activities do not constitute a project and, therefore, are exempt from review.

**POLICY CONSIDERATIONS:**

The annual budget process is being conducted in accordance with City Code Title 55. This maintenance district was initiated by the property owners in 1990. The property owners pay for the services provided or, if so desired, could discontinue the service with a majority petition and Council approval.

**ESBD CONSIDERATIONS:**





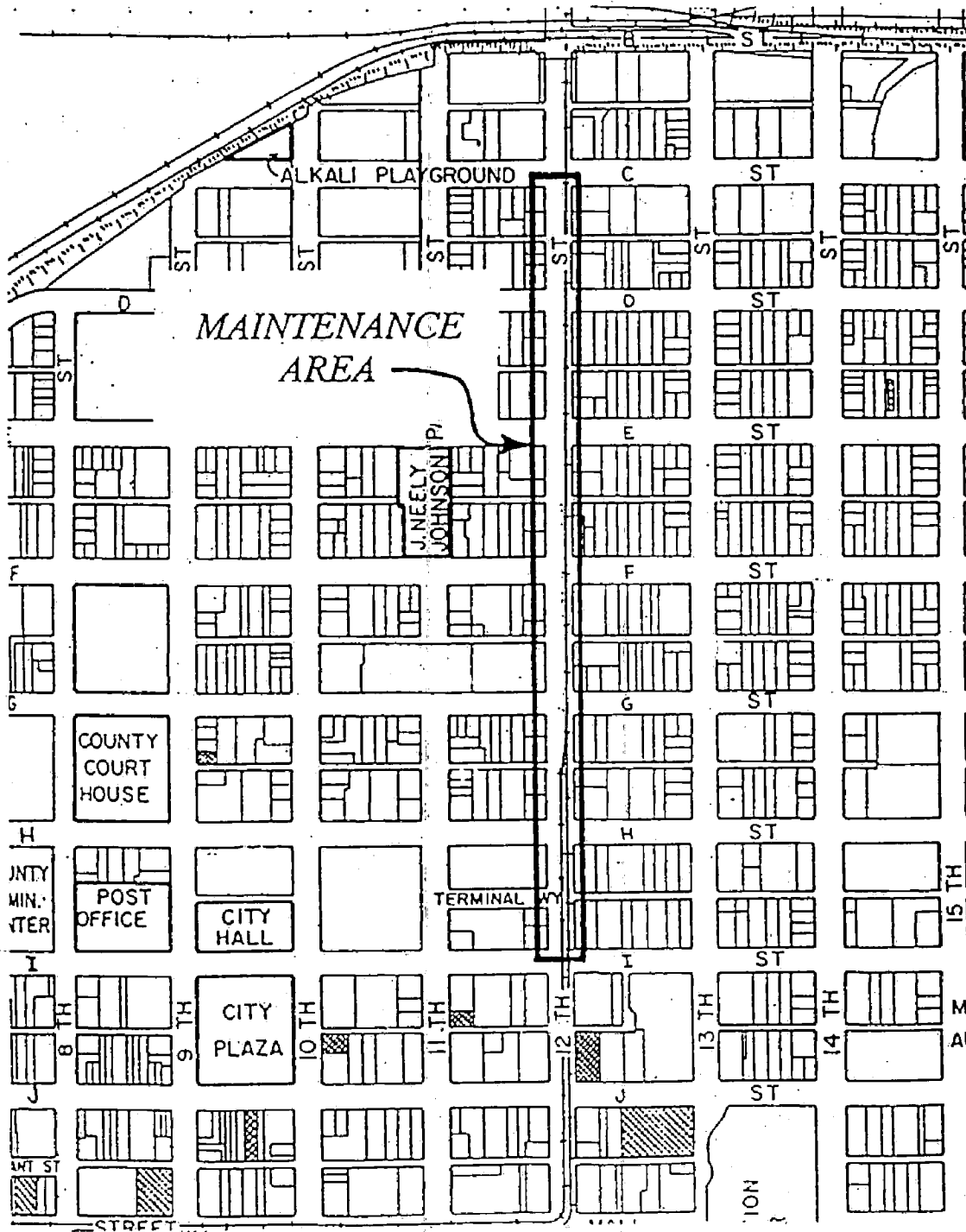

MAP

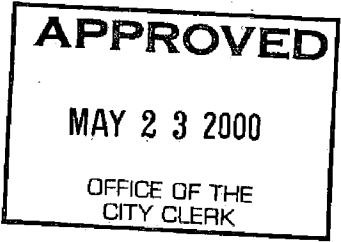
12TH STREET MAINTENANCE BENEFIT DISTRICT
