SUBJECT: Citation Authority for Public Works Classifications

SUMMARY:

The attached resolution amends Resolutions #85-329 and #85-746, which specify employees within the Animal Control Division of the Public Works Department to be granted citation authority pursuant to Ordinance #85-033. Adoption of the resolution is necessary due to personnel changes.

BACKGROUND:

Prior to passage of Ordinance #85-033, certain City employees were designated "Special Police Officers" by the City Manager in order to grant them citation issuance authority. Certain classifications within the Parking, Animal Control, and Solid Waste Divisions were included in the "Special Police Officer" designation. Due to confusion which arose between the "Special Police Officer" and Peace Officer status under the Penal Code, Ordinance #85-033 was drafted to change the way in which citation authority was granted.

The ordinance eliminated "Special Police Officer" status and specified that the City Manager submit to the City Council a list of persons within the classifications to be granted citation authority. The Council would then grant the authority by resolution.

Resolution #85-329 adopted on April 30, 1985 established the initial list of Animal Control Division employees granted citation authority pursuant to Ordinance #85-033. Additions and deletions to the original list were made in Resolution #85-746 adopted on September 25, 1985. Recent staffing changes require another modification to the list.
