SUBJECT: Bing Maloney Golf Course 9 Hole Addition (PN:OA36) - Project Approval and Bid Advertisement

SUMMARY

Plans and specifications for this project have been prepared. Approval of the plans and specifications and authorization to advertise for bids is recommended.

BACKGROUND

The City of Sacramento needs to construct additional golf courses to approach the guidelines established by the National Golf Foundation for the number of golf courses per 1000 population of an area. This area will construct a new nine hole golf course adjacent to the 18 hole Bing Maloney course.

A Categorical Exemption for this project was filed with the County Clerk of the County of Sacramento on May 5, 1986. The engineer's estimated construction cost is \$729,000.

FINANCIAL

Additional funds will be needed for this project. The estimated total project cost, including all planning, design and construction costs, is \$967,000. The current budget is \$525,000, which was approved in the Capital Improvement Program from Golf Funds. A loan has been requested from the City Retirement Fund for an additional \$935,000, making a total of \$1,460,000. The final budgetary recommendation will be made following receipt of bids.
