SUBJECT: Grant Application to Museum Program of the National Endowment for the Arts for the "Art Ark" Mobile Arts Education Program

### SUMMARY

A resolution is required to approve the submittal of an application to the Museum Program of the National Endowment for the Arts for a matching grant to support the "Art Ark" Mobile Arts Education Program.

### BACKGROUND INFORMATION

The Museum Program of the National Endowment of the Arts provides a 50 percent matching grant program for wider availability of museums projects. The requested \$25,000 grant will be used to support the "Art Ark" Mobile Arts Education Program directed toward elementary school students in 14 school districts, including the Sacramento City Unified School District, within Sacramento County. The "Art Ark" project was initiated in January, 1980 as a pilot program. Initial funds from County and corporate sources provided for the purchase of a 55 foot trailer and renovation into a mobile gallery. The arts education program provided the "Art Ark" is unique in that it introduces art concepts via the visual/performing arts, to both children and adults.

### FINANCIAL DATA

The 50 percent matching funds of \$25,000 for the requested National Endowment of the Arts grant will be solicited from corporate and State of California, California Arts Council sources and will include \$3,508 in indirect costs to the City for staff salaries and benefits during the period of the grant.



## RESOLUTION APPROVING APPLICATION FOR GRANT FUNDS UNDER THE NATIONAL ENDOWMENT FOR THE ARTS MUSEUM PROGRAM FOR THE ART ARK MOBILE ARTS EDUCATION PROGRAM

WHEREAS, The National Endowment for the Arts Museum Program has established the Matching Grant Program for Wider Availability of Museums, which provides funds to certain non-profit organizations for developing programs to increase the availability of museums to the public; and,

WHEREAS, the procedures established for the National Endowment for the Arts Program require the City of Sacramento, hereinafter referred to as "Applicant" to certify by resolution the approval of applications prior to submission of said applications; and

WHEREAS, said applications contain a certification that the applicant will comply with all federal, state, and local environmental, public health, and affirmative action requirements and all other appropriate codes, laws, and regulations prior to the expenditure of the grant funds;

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL HEREBY:

1. Approves the filing of an application for funding under the National Endowment for the Arts Museum Program; and,
2. Certifies that the Applicant understands the general provisions of the agreement; and,
3. Appoints the City Manager as agent of the Applicant to conduct all negotiations, execute and submit all documents including, but not limited to, applications, agreements, amendments, payment requests, and so on which may be necessary for the completion of the aforementioned project.
