SUBJECT: GRANT MODIFICATION AND AUGMENTATION - CRACK/ROCK IMPACT PROJECT

SUMMARY

The Sacramento Police Department is requesting approval to apply for an extension and augmentation of \$155,228 to the first year of the Crack Rock Impact Program - Sacramento (C.R.I.P.S.) grant. The extension and augmentation will fund the payment of overtime and other salary and operating expenses through December 31, 1989. The \$155,228 augmentation will be 100% funded by the State Office of Criminal Justice Planning (OCJP) with no cash match required by the City of Sacramento. Grant funds expended by the County Sheriff's Department are reimbursed by OCJP to the City of Sacramento and passed through to the County of Sacramento. The Police Department will receive \$82,555 and the Sheriff's Department will receive \$72,673 for a total of \$155,228.

It is recommended that the extension and \$155,228 augmentation be approved and the Police Department grant budget be augmented by \$82,555 for the 89/90 fiscal year.

BACKGROUND

On January 1, 1988, the Sacramento Police Department received grant funds in the amount of \$430,387 from the Office of Criminal Justice Planning (OCJP) to implement the law enforcement component of the Crack/Rock Impact Project (C.R.I.P.S.). This grant is a multi-agency grant encompassing the Sacramento Police Department, County Sheriff's Department, District Attorney's Office, and County Probation Department. The Police and Sheriff's Departments submitted a joint proposal with the Police Department responsible for the administration of the law enforcement component. Funds expended by the County Sheriff's Department are reimbursed by OCJP to the City of Sacramento and passed through to the County of Sacramento. The first year funding for the grant was originally from January 1, 1988 until December 31, 1988.

In December, 1988, the Police Department received a six month extension and augmentation of \$109,564 to cover the period from January 1, 1989, until June 30, 1989. The \$109,564 was funded 100% by OCJP with no cash match required by the City of Sacramento.

The Police Department is now requesting approval to apply for a second extension and augmentation of \$155,228. The extension would fund the grant until December 31, 1989. Again this amount would be 100% funded by OCJP with no cash match required by the City of Sacramento. The augmentation would pay for the overtime required by the three Police Officers and three Sheriff's Deputies funded by the C.R.I.P.S. Grant. The extension and augmentation will not effect third year funding of the grant.

FINANCIAL DATA

The augmentation for this grant is \$155,228 with \$82,555 going to the Police Department and \$72,763 going to the Sheriff's Department. This amount is funded 100% by OCJP with no cash match required by the City of Sacramento. The Police Department's 89/90 operating budget will be increased by \$63,424 as \$19,131 was encumbered during the 88/89 fiscal year. The grant budget is as follows:


RECOMMENDATION

## RESOLUTION AUTHORIZING THE EXECUTION OF A CONTRACT WITH THE OFFICE OF CRIMINAL JUSTICE PLANNING TO IMPLEMENT AN AUGMENTATION AND EXTENSION TO FIRST YEAR FUNDING OF THE CRACK/ROCK IMPACT PROJECT

WHEREAS the Sacramento Police Department desires to implement an augmentation and extension to first year funding of the Crack/Rock Impact Project funded by the Office of Criminal Justice Planning (hereafter referred to as OCJP),

NOW THEREFORE, BE IT RESOLVED that the City Manager of the City of Sacramento, or his designated representative, is authorized on its behalf to submit a request to OCJP for augmentation and extension of first year funding of the Crack/Rock Impact Project and is authorized to execute on behalf of the City Council any extensions or amendments thereof.

BE IT FURTHER RESOLVED that, upon receiving approval by OCJP of the \$155,228 augmentation and extension, \$72,673 will be received and administered on behalf of the County of Sacramento and the operating budget of the Police Department will be increased \$82,555 as follows:
