SUBJECT: ACCEPTED BID OF FIRE HOSE PURCHASE

After reviewing the bid specifications submitted for purchase of $2\frac{1}{2}$ " and $1\frac{1}{2}$ " fire hose, it is determined that Halprin Supply Company meets all the specifications required on our spec sheet.

Halprin is the second to low bid, L. N. Curtis was low bidder, but did not meet the hose specification in the following critical areas:

- 1. Test burst pressure where 1,000 PSI is required and their burst pressure was 900 PSI, 100 under specification.
- 2. Tensil strength of inner liner:

Spec's require 2,000 lbs and their hose only listed 1,600 lbs.

Therefore we recommend that you accept Halprin's bid as it meets our hose specification requirements.
