SUBJECT: Awarding Construction Contract - Alkali Flat 40 Units Elderly Housing Project

SUMMARY

Attached is a resolution by which you award the contract for the construction of the Alkali Flat 40-unit elderly housing facility located on the south side of "E" Street between 10th and 11th Streets to J. R. Roberts Corporation, the low bidder. The resolution also authorizes the Executive Director to enter into a contract with the low bidder on the basis of said bid.

BACKGROUND

On January 29, 1980, you adopted Resolution No. 2887 authorizing solicitation of bids for the construction of the above referenced facility. Bids were received and opened on April 16, 1980. The bid tabulation is attached for your review. The results indicate that J. R. Roberts Corporation is the the apparent low bidder.

FINANCIAL DATA

As of this date, funds in the amount of \$1,430,000 have been authorized for this Alkali Flat elderly housing project; \$600,000 from Project 2-A Housing Replacement Funds, \$775,000 from Alkali Tax Increment Funds, and \$55,000 from Alkali C. D. Carryover Funds. It is estimated that with the low bid of \$1,064,900, together with all miscellaneous costs such as architectural and engineering fees, art work, and Agency overhead, the total project cost to the point of 100 percent occupancy will be approximately \$1,285,000, well within the available funding.
