**SUBJECT: Amendment of Agreement with Sacramento Local Conservation Corps for Levee Maintenance**

SUMMARY

This report recommends that the City amend the agreement between the City and the Sacramento Local Conservation Corps for levee maintenance to extend the period of the contract from July 1, 1988, to June 30, 1989.

BACKGROUND

The City Council authorized the City Manager in 1987 to execute Agreement #87061 with the Sacramento Local Conservation Corps to perform maintenance work on the levee system that could not be performed by City personnel because of staffing and time limitations. This contract benefitted both the City and the Corps, which provides training and work experience for young people. The Flood Control and Sewers Division has used the assistance of the Corps to ensure that pressing maintenance work and clean-up was performed prior to the start of the rainy season. The Flood Control and Sewers Division requires the continued assistance of the Corps during the current fiscal year for the same work.

FINANCIAL

Extension of the contract through the current fiscal year will cost \$11,500. There have been funds budgeted for this work in the current budget of the Flood Control and Sewers Division (4-24-310-3165-4287). The total cost of the agreement now will not exceed \$21,500.

RECOMMENDATION




