I am a resident of midtown where I have lived with my family for over 20 years. We have three children two of whom will be attending Sutter Middle School in the fall. I would very much like them to be able to walk or bike to school, but I am very concerned that the blocked sidewalks under the freeway will prevent them from being able to do so safely. The lands of traffic under the overpasses extend all the way to the sidewalk — there are no bike lanes or other buffers. At the present time, the unhoused population living in that area is taking up the entire sidewalk, which forces pedestrians into the lane of traffic. I know this well because I run under the freeway multiple times each week and have to leave the sidewalk when I go under the freeway. If you are interested in criminalizing homelessness, ask yourself why you wish you criminalize being poor in public.

Measures like this roll back the rights of the people to enjoy the commons by either a.) eliminating the commons or b) only allowing property owners to enjoy the commons. There is increasingly nowhere people are allowed to be poor in public in this city. This measure reckons back to universally condemned measures like the "ugly laws" of the late 19th and 20th century. Stop criminalizing people who have little control over their material conditions and actually do your job to solve the housing crisis and build tenants' rights in this city.
