SUBJECT: Resurfacing of Tennis Courts at Curtis, Cabrillo and Hall Parks
(CC: 2120) - Fund Appropriation and Contract Award

SUMMARY

This project has been advertised for bids. Bids have been received and contract award is recommended.

BACKGROUND

On October 1, 1985, the City Council approved plans and specifications for this project and bids were received and opened by the City Clerk in the City Council Chambers on October 22, 1985. Bids received are as follows:

A & B Asphalt Sealing Co.	\$ 17,802.00
Central Stripping Service, Inc.	24,200.00
Malott and Peterson-Grundy	26,320.00

The estimated completion date for the project is February 1, 1986.

FINANCIAL

The City Council has approved \$12,200 in the Parks and Community Services budget from the General Fund for this project, of which \$11,400 is currently available. The Landscape Architect's estimated construction cost was \$13,200. It is proposed that an additional \$10,000 be appropriated from the Quimby Act Reserve Fund for this project. The attached Resolution was considered by the Budget and Finance Committee during their meeting of November 6, 1985 with a staff recommendation to approve the appropriation of funds.

RESOLUTION AMENDING FY 1985-86 CAPITAL IMPROVEMENT BUDGET
FOR THE DEPARTMENT OF PARKS AND COMMUNITY SERVICES
FOR THE TENNIS COURT RESURFACING PROJECTS

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. That the bids for resurfacing tennis courts at four park sites were over the budget amount.
2. That the City FY 1985-86 Capital Improvement budget for the Department of Parks and Community Services is hereby amended for:
 - a. Transferring \$2,800 from the Hall/Curtis/Cabrillo (miscellaneous) tennis court resurfacing C.I.P. No. 101-4521-2120 to the McKinley Park tennis court resurfacing C.I.P. No. 101-4521-2119.
 - b. Adding \$10,000 to the Miscellaneous Tennis Courts Resurfacing Project No. 101-4521-2120 from the Quimby Act Reserve fund No. 7-10-7012-0000-4599.
