

SUBJECT: Alkali Flat Redevelopment Plan - Community Plan Amendments and Rezoning to Reflect Updated Redevelopment Plan (M-243)

SUMMARY

On August 12, 1980, the City Council/Redevelopment Agency adopted amendments to the Alkali Flat Redevelopment Plan. Among the amendments were changes to the land use map. Concurrent with the hearing on the Redevelopment Plan, the City Council also conducted a hearing on proposals for zone changes.

This report transmits to the City Council for adoption a resolution to amend the Central City Plan (Land Use Element) to reflect the land use decisions made as part of updating the Redevelopment Plan. Also being transmitted for adoption is an ordinance to rezone those specific properties approved for a change by the Council on August 12, 1980.

RECOMMENDATION

The staff recommends the City Council adopt the attached resolution for amending the Central City Community Plan and the attached ordinance to rezone properties pursuant to carrying out the Land Use Element of the Updated Redevelopment Plan.




