#### SUBJECT: OXFORD/OAKMONT DRAINAGE IMPROVEMENTS (PN: WB66 and ZB31) CONTRACT AWARD TO J. BIRD AND SONS CO., INC. FOR AN AMOUNT NOT TO EXCEED \$597,110

#### LOCATION AND COUNCIL DISTRICT

The project is bounded by Woodlake Drive on the South, Del Paso Boulevard on the North and West, and Cantalier Road on the East (District 2).

#### **RECOMMENDATION**

It is recommended that the City Council accept the low bid of J. Bird and Sons Co., Inc. in the amount of \$597,110, award the contract, and increase funding of PN:WB66 by \$320,000.

SUMMARY

On March 29, 1994, the City Council approved plans and specifications for this project and authorized advertising for bids. Bids were received from seven (7) contractors and opened by the City Clerk on May 11, 1994. J. Bird and Sons Co., Inc. is the low bidder at \$597,110 and has met the goals for MBE/WBE participation.

Mascon/Flowline J.V. is the second low bidder at \$662,596 and has also met the MBE/WBE participation goals.

#### **BACKGROUND INFORMATION**

The project involves the replacement of the existing storm drainage system in the area of Woodlake Park. The existing storm drain pipes are insufficient to protect against heavy storms. On March 29, 1994 the City Council approved plans and specifications for this project and authorized advertising for bids. Bids were received from seven contractors and opened by the City Clerk on May 11, 1994.

The seven bids received were:

J. Bird & Sons Construction, Inc.	\$597,110*

Note: Contractors who apparently met MBE/WBE participation goals are indicated with (\*).

The engineer's estimated construction cost was \$581,000. The estimated project completion date is October, 1994.

## ENVIRONMENTAL DETERMINATION

The Environmental Services Division has conducted an Initial Study and determined that this project will not have a significant effect on the environment. A Negative Declaration has been published and filed pursuant to the California Environmental Quality Act.

## FINANCIAL CONSIDERATIONS

The revised estimated total project cost, including all planning, design, construction, and inspection is \$830,000. An estimated \$60,000 of this total is for water distribution system improvements. A budget amount of \$523,000 was approved for the drainage improvements (PN:WB66) as part of the Storm Drainage Fund Capital Improvement Program. The current unobligated balance for this fund as of May 26, 1994 is \$392,614. An additional \$320,000 is required to complete this project. Additional funds are available in the Storm Drainage Improvements Base CIP Reserve (PN:WE71) with an unobligated balance of \$1,939,869 and in the Miscellaneous Water Main Improvements (PN: ZB31), with an unobligated balance of \$555,085. It is, therefore, requested that \$260,000 of the unobligated amount for PN:WE71, and \$60,000 of the unobligated balance of PN: ZB31, be transferred to the Oxford/Oakmont Drainage Improvements PN:WB66.

#### POLICY CONSIDERATIONS

This action is consistent with Chapter 58, Article III, Section 58.301 of the City Code concerning advertisement for bid and Resolution No. 93-149 relating to MBE/WBE participation goals and policies adopted by the City Council on November 2, 1993.

#### MBE/WBE EFFORTS

This project included MBE and WBE participation goals of 10.57% and 9.5% respectively, as required by Resolution 93-149 relating to MBE/WBE participation goals and policies, adopted by the City Council on November 2, 1993. Award of this contract is contingent upon the responsive low bidder either meeting the project MBE/WBE participation goals or making adequate Good Faith Efforts to meet the goals. The MBE/WBE participation achieved by the three low bidders as identified in their bids, is listed in the following table:

Staff has determined that J. Bird and Sons Co., Inc. has met the MBE/WBE participation goals established for the project. Staff recommends that the City Council accept the low bid of \$597,110 by J. Bird and Sons Co., Inc. and award the contract.

Plans and specifications were sent to seven (7) plan rooms and construction services organizations for publication and use by the construction industry of Northern California. There are four (4) organizations on the distribution list that are directly involved with outreach to MBE/WBE contractors.

SUBJECT: OXFORD/OAKMONT DRAINAGE IMPROVEMENTS (PN:WB66)

Please confirm that the stated findings for the low bidder's MBE/WBE participation are acceptable. The low bidder, J. Bird and Sons Co., Inc., with an unadjusted bid of \$597,110, appears to meet both the MBE & WBE goals. A participation of 10.89% MBE and 11.69% WBE entitles this bidder to an additional 5% reduction of his bid or \$29,856. \$25,000 is the maximum allowed reduction and therefore should be subtracted from the unadjusted bid for determination of the actual low bidder. Since the appearant low bidder received the maximum allowed reduction it is impossible for a higher bidder to compete.

We have verified the following:

- 1. All companies on the submitted Designation of Subcontractors form are certified with the City of Sacramento per LGFS.
- 2. All MBE/WBE trucking will be performed by MBE/WBE truckers in MBE/WBE trucks qualifying for 100% credit towards MBE/WBE goals.

RESOLUTION AUTHORIZING THE CITY MANAGER AND CITY CLERK TO SIGN AND EXECUTE A CONTRACT WITH J. BIRD AND SONS CONSTRUCTION, INC. FOR OXFORD/OAKMONT DRAINAGE IMPROVEMENTS (PN: WB66)

BE IT RESOLVED BY THE SACRAMENTO CITY COUNCIL THAT:

- 1. Storm Draiange Funds of \$260,000 are appropriated from the Drainage Improvements Base CIP Reserve (425-500-WE71-4820) to the Oxford/Oakmont Drainage Improvements project (425-500-WB66-4820).
- 2. Water Funds of \$60,000 are hereby defunded from the Miscellaneous Water Main Improvements (PN:ZB31) and transferred to the Water Fund Contingency Reserve (413-710-7012-4998).
- 3. Funds in the amount of \$60,000 are appropriated from the Water Fund Contingency Reserve (413-710-7012-4998) to the Oxford/Oakmont Drainage Improvements project (413-500-WB66-4820).
- 4. The City Manager and City Clerk are authorized to sign and execute a contract with J. Bird and Sons Co., Inc. for the Oxford/Oakmont Drainage Improvements (PN: WB66) in an amount not to exceed \$597,110.
