Extending Time on Contract for Improvement Proceeding No. 4863, Fig Street Assessment District

BACKGROUND INFORMATION

The Council awarded a contract to Teichert Construction on April 3rd, 1979 for constructing concrete curbs, gutters and sidewalks, asphaltic concrete pavement, storm sewers, sanitary sewers, drainage facilities, lower existing water mains and a street lighting system complete in the above named Assessment At the time of signing the contract, the completion date was scheduled for January 11th, 1980. Since that time, two extensions of time have been granted by the Council making the current completion date July 9th, 1980. The work will not be finished by that time, however, due to the inability of the electrical subcontractor to perform, making it necessary to secure another electrical subcontractor.

RECOMMENDATION

It is recommended, therefore, that the Council grant an extension of sixty days to Teichert Construction by adoption of the attached Resolution Extending Time on Contract.
