#### Adopting the 2025 Regular Meeting Schedule for Sacramento City Council

#### BACKGROUND

- A. The Ralph M. Brown Act (California Government Code 54950 et seq.) requires that legislative bodies provide the time and place for regular meetings by ordinance, resolution, bylaws, or by whatever other rule is required for the conduct of business by that body.
- B. Per City Charter Section 31, the City Council shall hold regular meetings and provide the time, place, and manner of holding its meetings by annual resolution. A majority of regular council meetings shall be held after 5:00 p.m. All meetings of the council shall be open to the public, except as permitted by state law.
- C. The City of Sacramento observes the following holidays: New Year's Day, Martin Luther King, Jr. Day, Presidents' Day, Cesar Chavez Day, Memorial Day, Independence Day, Labor Day, Veterans Day, Thanksgiving Day, Day after Thanksgiving, Christmas Eve (half day), Christmas, and New Year's Eve (half day). The City of Sacramento shall refrain from holding legislative meetings on the following additional holidays: Passover, Juneteenth, Rosh Hashanah, Yom Kippur, Native American Day, Indigenous Peoples' Day, Halloween, and Hanukkah.
- D. City Council recess is at least two weeks in July and December. No legislative meetings are held while the City Council is on recess.

### BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

#### **SECTION 1.**

The Sacramento City Council 2025 regular meeting schedule as shown in Exhibit A of this resolution is approved.
