SUBJECT: Citation Authority for Parks and Community Services Classifications

SUMMARY

The attached resolution amends Resolution #89-024 which specifies employees within the Parks and Community Services Department be granted citation authority pursuant to Ordinance #85-033. Adoption of this resolution is necessary due to personnel changes.

BACKGROUND INFORMATION

Prior to passage of Ordinance #85-033, certain City employees were designated "Special Police Officers" by the City Manager in order to grant them citation issuance authority. Classifications within the Parking Division, Animal Control Division, and Solid Waste Division were included in the "Special Police Officer" designation. Due to confusion, which arose between the "Special Police Officer" and Peace Officer status under the Penal Code, Ordinance #85-033 was drafted to change the way in which citation authority was granted.

The ordinance eliminated "Special Police Officer" status and specified that the City Manager submit to the City Council a list of persons within each classification to be granted citation authority. The Council would then grant the authority by resolution.

FINANCIAL IMPACT

This action is consistent with city policy granting citation authority.

RECOMMENDATION

It is recommended that the City Council approve the attached resolution amending Resolution #89-024 granting citation issuance authority to certain employees within the Parks and Community Services Department.


