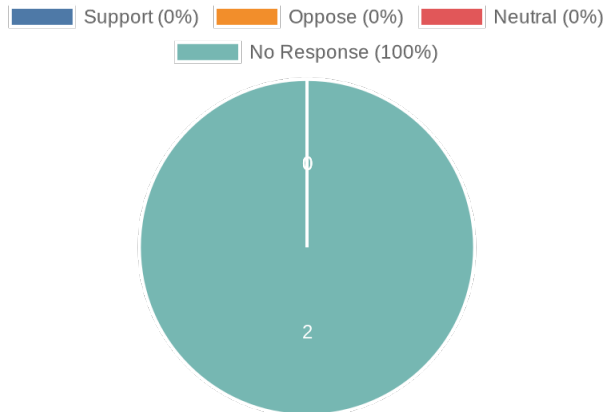

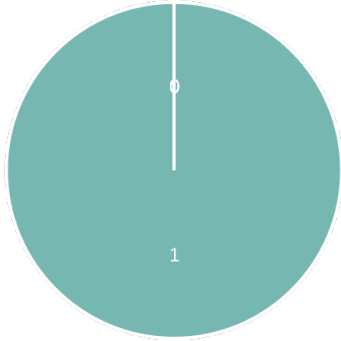
### Overall Sentiment

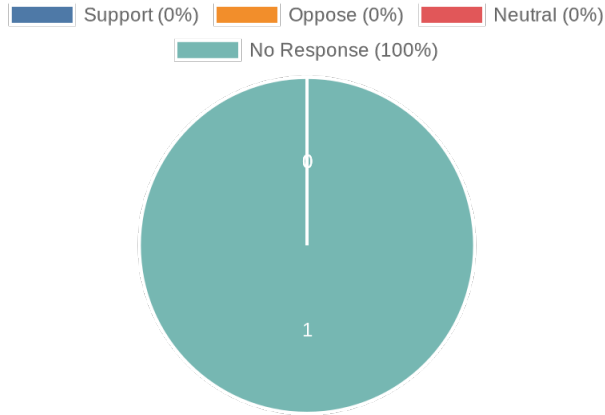
