The applicant is requesting entitlements to allow the development of a hotel, offices, and related facilities on 14.52+ acres in the existing Employment Center (EC-40) zone and the proposed General Commercial (C-2) zone within the Arena Corporate Center Planned Unit Development (PUD). This proposal requires the following entitlements: Rezone, Tentative Map, and Site Plan and Design Review. At this time, the applicant is requesting full entitlements for the hotel and schematic approval for the remainder of the uses, including offices, employment center use, and a parking structure. Future site plan and design review entitlements will be necessary prior to development of the remainder of the project site, including offices, employment center uses, and a parking structure.
