Resolution Amending Resolution No. 82-544 by Extending the Payment Period for the \$400,000 Loan to the American River Flood Control

District for Levee Repairs at River Park

SUMMARY:

SUBJECT:

Submitted is a resolution amending Resolution No. 82-544 by extending the payment period for the \$400,000 loan to the American River Flood Control District (ARFCD) for repair to the American River Levee from one to four years. It is recommended that the resolution be adopted.

BACKGROUND:

On August 3, 1982 the City Council passed a resolution authorizing the issuance of a loan for \$400,000 to the ARFCD to be used to pay the cost of the repair to the American River levee adjacent to River Park. The funds were to come from the Sewer Fund balance and the resolution specified that they were to be repaid within one year. Funds to repay the loan were to be derived from a benefit assessment district which included a large portion of the City. The County is currently in the process of developing tax bills and it has come to staff's attention that repayment of this loan in one year will result in a disproportionally high benefit assessments to some property owners. This is the case because the ARFCD's operating budget is \$400,000 per year and, therefore, the repayment of the loan doubles their budget. In order to alleviate this situation, it is staff's opinion that the loan should be made repayable over a four year period at no interest instead of the one year period. If this is done, the ARFCD will only have to raise \$500,000 instead of \$800,000 which would significantly lower the benefit assessment.

FINANCIAL:

Funds utilized for the loan were from the Sewer Fund balance and are considered an asset whether the loan is outstanding or not. Therefore, the fact that the loan is being paid off in four years instead of one year will not affect the bond convenances and consequently will not require an increase in the sewer rates.

RECOMMENDATION:

It is recommended that Resolution No. 82-544, adopted August 3, 1982, be amended by extending the payment period for the \$400,000 loan to the ARFCD from one to four years by passage of the attached resolution.
