

## BACKGROUND INFORMATION

On September 14th 1982, the City Council approved plans and specifications for Del Paso Heights Assessment District No. 5 and bids were received and opened by the City Clerk in the Council Chambers on October 5th, 1982. Bids received are as follows:

Teichert Construction Granite Construction Company R. C. Collet, Inc. \$756,047.60 \$777,925.05 \$822,650.00

The low bid of Teichert Construction, in the amount of \$756,047.60 is 6.85% below the Engineer's Estimate.
