SUBJECT: Resolution Approving Negative Declaration for Fire Station No. 11

SUMMARY:

The Environmental Coordinator has reviewed the subject project and finds that it will not have a significant adverse effect on the physical environment and therefore recommends that the project and a Negative Declaration be approved by the City Council.

BACKGROUND:

In accordance with State EIR Guidelines for Implementation of the California Environmental Quality Act of 1970, dated December 1976, an Initial Study was performed. As a result of this study, it was determined that the Fire Station No. 11 would not have a significant adverse effect on the physical environment and a draft Negative Declaration was prepared. On September 11, 1980 the Negative Declaration was filed with the County Clerk. On September 15, 1980 Notice of Opportunity for Public Review of the draft Negative Declaration was published in The Sacramento Union. The appropriate length of time has elapsed for receipt of comments regarding the Negative Declaration, with no comments having been received.

RECOMMENDATION:

The Environmental Coordinator recommends that the attached resolution be passed which will:

1. Determine that the proposed project will not have a significant effect on the environment.
2. Approve the Negative Declaration.
3. Approve the project.
4. Authorize the Environmental Coordinator to file a Notice of Determination with the County Clerk.


