SUBJECT: Crocker Art Museum Division - Appropriation Increase
For The Art Ark Mobile Unit Outreach Program Grant

SUMMARY

This report recommends a \$7,500 increase to the FY 1980-81 budget of the Crocker Art Museum Division to reflect Sacramento County General funds granted to support a museum outreach program and related operating expenses.

BACKGROUND INFORMATION

The Sacramento Board of Supervisors, on December 9, 1980, approved the allocation of general funds to benefit cultural and civic groups of the Sacramento community. Funds are distributed in accordance with criteria and a timetable established by the Board.

On November 12, 1980, the City Council adopted Resolution No. 80-738 approving the application for the grant. The City of Sacramento and the County of Sacramento have executed City Agreement No. 1980-81 AFA-8 for this program.

FINANCIAL DATA

The grant of \$7,500 will be funded by Sacramento County general funds. No City matching funds are necessary.

RECOMMENDATION

It is recommended that the City Council, by resolution, approve an increase in appropriations for \$7,500 to fund an outreach program of the Crocker Art Museum.

RESOLUTION AMENDING THE CITY BUDGET FOR FY 1980-81
FOR THE DEPARTMENT OF COMMUNITY SERVICES
(CROCKER ART MUSEUM - ART ARK OUTREACH PROGRAM)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The receipt of a grant from the County of Sacramento requires an appropriation increase of \$7,500 for the budget of the Department of Community Services.
